NARRC Organizations Adjust Support For Customers/Staff During Virus Interruption

During the Covid-19 Pandemic crisis all NARRC organizations have responded with various remedies in order to support customers, board, and staff. A few of the adjustments include:

- Rotate staff working at the office
- Reduce the 40-hour work week
- Arrange for staff to work at home
- Alternate staff checking on mail
- Maintain social distancing

We all realize this crisis is not the fault of customers or employees. Other adjustments implemented are:

- 1. Staffs continue to provide all services to their customers and processing all written or telephone requests for assistance.
- Posting of payments continue to be made as timely as practical and some are extending grace periods and forbearances to clients affected by the pandemic.
- 3. Some offices have offered borrowers a three-month period of interest-only payments and extended the loan term by three months.

We are not aware of any employees who have been laid off, furloughed, or dismissed. Likewise, all staff are continuing to receive their full-time salary, regardless of actual hours worked, and they are maintaining the annual and sick leave they already accrued.

Plans Modified During NARRC 2020 Mid-Year Board Meeting

2020 Wichita, KS Meeting Rescheduled to 2022

Because of the uncertainties with the Coronavirus and concerns to protect NARRC members, the NARRC board decided to cancel the Wichita, KS 2020 Annual Conference and reschedule it to the fall of 2022.

The Kansas Homestead Rehabilitation Corporation will renegotiate arrangements with the Wichita hotel. They will provide an update during the 2021 Annual Meeting in Richmond, VA. We appreciate all the extra efforts the Kansas staff and Board will exert to reschedule and rearrange the 2021 Annual Meeting to the fall of 2022.

2021 Richmond, VA Annual Conference

Plans are progressing to celebrate NARRC's 50th Anniversary. Because there will not be a 2020 annual conference, which would have been NARRC's 49th, the 2021 meeting will not officially be the 50th Annual Conference. Therefore, the 50th Anniversary Committee recently announced this will NARRC's 50th Celebration.

The Virginia Department of Agriculture staff continues to work closely with the 50th Anniversary Committee. They have some very interesting plans, including tours, speakers, and historical panel discussions. Because the Virginia staff will not be able to provide a presentation at the 2020 annual meeting, their video will be distributed to everyone later this year along with other updates.

2023 Mississippi Annual Conference

The Mississippi Rural Rehabilitation Corporation is still planning to host a future annual meeting, but one year later than they originally planned. Dates/location TBD.

Election of NARRC Board and Officers

The current NARRC Board and Officers have agreed to continue serving in their respective positions until the next election on Wednesday, September 22, 2021 in Richmond, VA. A big **THANK YOU** to the Board and Officers for serving for a second consecutive year.

• Checking Account

With **Vernon and Jeannie Eagan's** excellent help, and **President Hutchins'** guidance, \$11,929.46 was transferred from Regions Bank checking account in Arkansas to Wells Fargo checking account in Iowa.

• Money Market Account and CDs

NARRC Treasurer, **Steve Ferguson (IA)** identified options for the NARRC Finance Committee of **Don Jacka (KS), Tony Minicozzi (AR), and Larry Mack (FL)** to transfer NARRC's Money Market account and two CDs to Iowa. The NARRC Board approved the Finance Committee's recommendation to transfer funds from Telco Credit Union in Arkansas to GreenState Credit Union in Iowa as follows:

- 2. CD#1 = \$10,684.22 at 2.13% for 13 months
- 3. CD#2 = \$17,012.77 at 2.23% for 19 months

50 YEARS OF NARRC TRIVIA

Below are a few trivia items to help you prepare for NARRC's 50th Annual Celebration in 2021.

- 1. In April 1934, a Rural Rehabilitation Division was established in FERA (Federal Emergency Relief Administration). Funds were only for rural areas.
- By 1935, forty-five Rural Rehabilitation Corporations were formed; only Connecticut, Delaware and Rhode Island did not form a corporation; those formed in Maryland and Massachusetts never functioned.
- On February 22, 1971, Mr. Drew Cloud, Executive Secretary of the New Mexico Rural Rehabilitation Corporation announced a meeting to be held in Biloxi, Mississippi during March 11 and 12, 1971.
- On March 11, 1971 representatives from fifteen state corporations met at Biloxi, MS. Those in attendance were: Marvis B. Roberts (FL); Col. E.P. Scott (FL); Byron; Kirkland (GA); Joe Gillman (IA); Jim Rowen (IA); Nyle L. Katz (MI); Joe Pensien (MI); T.B. Fatheree (MS); Vyvian Walker (MS); Robert L. Fowler (MO); Roger Sandman (NE); Drew Cloud (NM); Henry R. Sink (NC); O. Leonard Orvedal (ND); T. G. Stratton (OK); John L. Neely, Jr. (TN); Walter T. McKay (TX); Joseph H. Francis (UT) and Walter H. Ebling (WI).
- 5. Thirty-nine men and women, from 20 states have served as NARRC President: 5 of these dedicated NARRC Officers served multiple years as President.
- The NARRC 2021 Annual Conference will be called our "50th Anniversary Celebration" although it is technically our 49th annual conference. The title is most appropriate since NARRC was founded in 1971.
